- Created by Danny and Brenda Cowart in honor of their daughter who was born with Trisomy 18
- Opened in June 2010
- Brandi's Hope provides community services to adults with intellectual and developmental disabilities ages 18+
- **Goal and Purpose:** Support individuals the way they choose to be supported. Choice is the fundamental driving force in their philosophy.

#### Services Provided

- Home and Community Supports
- Adult Day Services
- Prevocational Services
- Supported Employment Services
- Community Respite Services
- In-Home Respite Services
- Behavior Support/Intervention Services
- OT, PT, ST



#### Home and Community Supports

- For individuals that live in Brandi's Hope housing
- Each person has their own direct support professional
  - Ensures daily living needs are met
  - Ensures adequate functioning in the home and community
  - Provides safe access to the community
- Automated telephone clock in system

#### **Adult Day Services**

- Provide support that an individual needs and request to help them have a meaningful day
- 8am-3pm
- Transportation to and from Brandi's hope is provided if needed
- Activities promote self help skills, socialization, work/vocation participation, and leisure/fun
- Activities also extend into community settings

#### **Prevocational Services**

- Provided to individuals who are not expected to join the workforce within one year and are no longer eligible to receive educational services
- Activities are directed to teach general skills
  - Communication skills
  - Teamwork
  - Personal management skills
  - Problem solving skills

#### Supported Employment Services

- Provide support necessary to achieve and maintain employment
- Individual creates their own employment goals
- Site manager and/or direct support professional checks in with employer to ensure individual is an effective team member



#### Community and In-Home Respite Services

- Provided when other types of services are not available such as the evenings or weekends
- Provided when the usual care giver is unable to provide care due to hospitalization, illness, or injury.
- Ensures that their family member is in a safe place and receiving the care he/she needs



#### **Behavior Support/Intervention Services**

- Provided to individuals whose behavior problems cause them to:
  - Not be able to benefit from other services provided
  - There is a concern for the individual to cause harm to themselves or others
- Site manager meets with family to discuss recommendations and provide information regarding community resources

#### PT, OT, and ST

- Ensure that services are provided and/or accessed
- Provide transportation to and from therapy services
- For individuals living in Brandi's Hope housing, the direct support professional will attend tx sessions, if requested, to learn orthotic management, stretching techniques, and other HEP activities



## **Referral Process**

#### Intellectually Delayed/ Developmentally Delayed Waiver

- NMRC in Oxford to be evaluated to obtain the ID/DD Waiver
- ID/DD waiver is Medicaid funded
- Provides eligibility to receive home and community based services like Brandi's Hope

- There are no age restrictions as to when the evaluation can be completed
- To arrange for an evaluation call: 662-513-7728

#### Beginning Services at Brandi's Hope

- Once the ID/DD waiver is obtained, the individual gets placed on the Brandi's Hope waiting list
- The date of the evaluation determines the spot on the waiting list
- Can be 10+ years before services are received

- If residential services are desired, it must be included in the evaluation POC
- The primary caregiver can contact NMRC to request to add residential services
